Minutes of the Parish Council Meeting held Wednesday 23rd April 2025

Present Cllr Ham (Chairman presiding), Banks, Moulding, Evans, Pearce, and Townsend.

1. Public Forum

1.1 The Unknown Woman in War will be unveiled at a small ceremony on Thursday 8th May at the junction of Beacon View with Anchor Road starting at 5.30pm.

- 1.2 Cllr Evans offered to empty the bin at Roman Way if it was owned by Coleford Parish Council and we were having to pay Somerset to empty it. The Clerk confirmed that it was a Somerset owned bin and therefore not one for use to fund.
- 1.3 The Shepton Local Community Network meeting scheduled for 28th April 2025 has been postponed to the 13th May.
- 1.4 A parishioner had expressed concern that a tree at Careys Mead was diseased. The Clerk noted that it was on Somerset owned land so had reported it via the Somerset website.

6. Planning updates

Cllr Ham and Townsend met with the Somerset planning officer to discuss the Gladman and Rainier appeals. It was established that there is little that the Parish Council can do to fight either application. The changes made at the end of last year to the national planning policy meant that the harm caused by a potential planning developments had to be severe to be stopped and it is not felt that either of these applications fall into that category.

Although we had hoped that we had good grounds for it be challenged over highway safety, Somerset Council planning office have no evidence from the Highway Authority of any incidents within 500m of the site over the last 5 years and is therefore deemed safe.

The housing need for Somerset has increased from 420 dwellings, to 620 and are now being told that its 990 new dwellings per year. The new local plan is unlikely to be approved by 2029.

It was agreed that the Council should make the Planning Inspectorate aware that it has not been given the full consultation period to seek expert advice and that it would like extra time to do this. Permission would also be sought to become a Role 6 participant in the limited enquiry which is due to take place on the 10^{th} and 11^{th} of June.

If extra time is allowed then the Council will need to seek quotes to help decide whether to instruct a Transport specialist at a future Parish Council meeting.
